## HOST® HA3 Applicator Warranty

1. This limited **1 Year** Warranty applies to HOST Applicators used in the United States when purchased from a HOST Authorized Distributor. Outside the United States, Applicators are warranted by the local distributor.
2. This Applicator is warranted to be free from defects in materials and workmanship when used solely for the purpose of applying HOST® Dry Cleaner to carpets. This Warranty applies to original Purchaser only. If Applicator is sold, transferred or lost, this Warranty becomes void.
3. In the event of failure of a part or parts within **1 year** from date of delivery to Purchaser, and upon inspection the Manufacturer is satisfied that failure is due to defective materials or workmanship, such defective parts will be repaired or replaced at Manufacturer's expense.
4. This Warranty does not cover damages caused by accident, neglect or abuse, nor does it cover expendable parts subject to normal wear.
5. Applicators requiring repair under the Warranty must be sent to the Manufacturer freight prepaid. Repairs will be made and the Applicator returned to the original Purchaser freight prepaid in the USA
6. When Applicators under this Warranty are returned with parts or accessories missing, the Purchaser will be charged for all parts and labor by the Manufacturer. After the Warranty has expired, a rebuilding charge will be quoted after Manufacturer has inspected the Applicator. Overhauled Applicators are warranted for 90 days.
7. This Warranty gives you specific legal rights and you may also have other rights which vary from state to state.
